IPG Sustainable Solutions: WATER-ACTIVATED TAPE

DEEPENING OUR COMMITMENT TO SUSTAINABILITY IN PACKAGING AND PROTECTIVE SOLUTIONS

Sustainability is a key strategy at IPG[®]. Thus, the values of a safe work environment, environmental stewardship and good corporate citizenship are deeply embedded in IPG's culture. Customers, distributors, employees and investors are increasingly interested in working with companies that prioritize these values in their ongoing business. We live these values every day through our effective resource management, product innovation and our commitment to meet, or exceed, our customer's expectations.

This report highlights IPG's commitment to the Circular Economy with recyclable tapes and our natural kraft Water-Activated Tape (WAT) product line, which is now Cradle to Cradle Certified[®] (C2C Certified[®]) Bronze. IPG's WAT product line defines what sustainable products are. We are proud of these accomplishments, and believe they demonstrate a positive contribution to the global community in which we live, work, and serve.

IPG WATER-ACTIVATED TAPE CAN BE RECYCLED

All of IPG's WAT is recyclable with the carton it is applied on. Cartons are one of the most widely recycled packaging products in use today. When you use IPG's WAT tape to seal the carton, the paper from the tape contributes to the recycling stream with the corrugate.

IPG's paper tapes take recycling one step farther. Our WAT paper tape has passed the Western Michigan University Old Corrugated Containers (OCC) Equivalency (WMU OCC-E) testing protocol, making it the first certified recyclable carton sealing tape! These products, without reinforcing fibers, are completely made from recyclable paper. Some of these products are made with up to 50% recycled paper to help support circularity.

The WMU OCC-E test protocol was developed modeling guidelines from the Fibre Box Association (FBA). FBA members represent about 95% of the corrugators in the United States. The protocol was developed using untreated OCC as the control. OCC is a valuable and sought-after source of secondary fibers.

Contamination rates are a major impediment to recycling programs in the US and reducing contamination in our recycling streams is important to successful recycling. IPG customers that are committed to using recyclable packaging can now use a certified recyclable tape on their cartons.

Unlike other certifications, which tend to focus on a singular measure of sustainability, C2C Certified assesses all aspects of product design and manufacturing by evaluating a product's performance across five categories:

- Material Health
- Product Circularity
- Clean Air and Climate Protection
- Water and Soil Stewardship

Social Fairness

As of February 2020, IPG's natural kraft WAT was C2C Certified Bronze. In the production of WAT, the Material Health Category requires IPG to evaluate all chemicals down to 100 parts per million to determine each chemical's effect on human and environmental health. The C2C Certified Product Standard requires WAT to contribute to the Circular Economy, which means the product is able to be recycled and/or uses recycled materials in its production. IPG's Manufacturing Department was audited to ensure that both the Water & Soil Stewardship and Clean Air & Climate Protection Categories have minimal impact on the environment. Social Fairness, the final category, requires IPG to be accountable to all stakeholders within the company and the communities where they conduct business.

The C2C Certified Product Standard audits endeavor to ensure that IPG's customers receive a product that leads to a sustainable future.

UL PRINTING CERTIFICATION

IPG's Menasha, Wisconsin facility is an authorized UL label printer. Authorized UL label printers can print UL logos following UL procedures and documentation regulations. Any end user that wants to have UL printed on their tape must submit their artwork to UL. Once the artwork has been approved by UL, IPG can produce the UL logo. The signed approval from UL accompanies the print proof from our customers. The UL audits our IPG Menasha location each quarter.
